- 3) lunch and breakfast on premises providing you with time to catch up with colleagues and make new connections; and
- 4) the annual business meeting to update you on OPEG activities past, current, and future.

This year's theme is *Challenges in Evaluation*. The focus is on the issues and solutions as it related to the theory and practice of evaluation.

Submission Requirements

When submitting your proposal, please choose from one of the following options:

- 1. **Full session presentation**: This is a longer session of approximately 45-60 minutes that is focused on a single topic. Examples of such sessions include: symposium, panel discussion, skill-building session or workshop, or demonstration.
- 2. **Brief presentation**: Presentation of 10-15 minutes that is focused on a single topic.
- 3. **Poster presentation**: A visual presentation that will be on display during the Exchange. You will have a chance to stand by your poster during a scheduled poster session to answer questions.
- 4. **IGNITE session**: A 45-60 minute session consisting of 4-6 IGNITE presentations plus 10-15 minutes (mandatory) for audience discussion that is focused around a specific topic. For more information on IGNITE, check out the Reilly site or Stephanie Evergreen's IGNITE webinar on the AEA website.
- 5. Other presentation type: Provide as much detail as for the Full Presentation plus detail that makes your presentation different from the presentation types above

Proposals will be reviewed by the OPEG Program Committee using blind review and will be scored based on the following criteria:

- Extent to which the proposal addresses the theme of *Challenges in Evaluation*.
- Proposal's relevance to evaluation practice, methodology, and utility.
- The technical quality of the proposal clarity and coherence of writing, degree to which the proposal articulates relevance to the field of evaluation, and clarity of objectives and purpose.

Notification of review results will be sent out by email to the individual submitting the proposal by February 26, 2016. It is the responsibility of each submitter to inform any additional participants listed in the proposal.

The primary presenter must be a paid member of OPEG by the time of the Spring Exchange (invited speakers may be exempted from this requirement). Copies of presented materials in Microsoft Office or Adobe PDF format must be submitted to the Program Committee by May 2, 2016 for posting on the OPEG web site.
